**Senator Kirsten Gillibrand - Remarks on Bitcoin** 18:30 AM

In her first Senate term, Kirsten Gillibrand led the repeal of "Don't Ask, Don't Tell" and passed the 9/11 health bill for first responders and survivors. She secured benefits for veterans exposed to toxic burn pits, made domestic gun trafficking a federal crime, and reformed the military justice system. Gillibrand enacted the STOCK Act to prevent Congress insider trading and was the first to post her meetings, earmark requests, and financial disclosures online. Advocating for working families, she champions paid leave for all working Americans. She chairs the Senate Armed Services Subcommittee on Emerging Threats and Capabilities and serves on the Intelligence, Agriculture, and Aging Committees. Gillibrand lives in Albany, New York, with her husband Jonathan, their sons Theo and Henry, and their labradoodle, Maple.



#### Natalie Smolenski - Opening Keynote | 8:40 AM

Natalie founded and leads the Texas Bitcoin Foundation, a public charity dedicated to original research and education about Bitcoin and political economy. Previously, Natalie co-founded Learning Machine, a SaaS company that built the first Bitcoin-based digital identity wallet and helped launch the decentralized identity movement. She exited Learning Machine to Hyland, where she currently leads business development. She also co-founded the Texas Blockchain Council, a professional trade association representing the Bitcoin industry in Texas. Natalie is also a political and economic anthropologist developing a theory of value. She writes about Bitcoin policy as a Senior Fellow at the Bitcoin Policy Institute.



Mike Brock - What Makes Bitcoin Valuable? | 9:50 AM

Mike leads TBD, which focuses on cryptocurrency and decentralized finance. Mike has held a number of leadership positions at Cash App and was responsible for setting up Spiral, an open source, separate Block initiative focused on a more accessible global financial system for the internet. Prior to Block, he was a principal software engineer and project lead at Red Hat.



### Lyudmyla Kozlovska - How I Resisted Three Dictators with Bitcoin | 10:00 AM

Lyudmyla Kozlovska, a human rights defender from Ukraine, is president of the Open Dialogue Foundation (ODF). Since the Russian invasion of Ukraine in February 2022, ODF has provided Ukrainian refugees and the military with support worth €5,9 mln. The speed of Bitcoin and USDT has been a key factor in raising emergency funds from donors in the EU and the US and to provide humanitarian aid to Ukrainians. Kozlovska will present how debanking/de-risking of the ODF became a consequence of transnational persecution: how authoritarian and hybrid regimes disempower human rights activists, obstructing humanitarian aid for Ukraine and harassing their critics in the EU. Based on own experience, Kozlovska has launched an EU-wide campaign aimed at sharing with regulators the best practices and experiences of civil society activists employing Bitcoin to tackle financial exclusion and oppression. Despite the disconnection from the banking system, the use of digital assets enabled them to continue their human rights, humanitarian and environmental efforts all over the world (e.g. in Poland, Belgium, Palestine, Venezuela, Belarus and Russia). Since the EU and US attempt to regulate digital currency, human rights defenders advocate the lawmakers to take these issues into consideration.



## Anna Chekhovich - Why Russian Dissidents Use Bitcoin Lessons from Navalny's Foundation | 10:15 AM

Anna Chekhovich is the financial director of the Anti-Corruption Foundation (ACF), the leading opposition power in Russia, founded by Alexei Navalny. Working on major opposition projects, the ACF has been using Bitcoin technology since 2016 to avoid government surveillance. Crypto assets helped the foundation maintain opposition activities in Russia, especially when local bank accounts were under constant attacks from the government. Even after the foundation's relocation to Europe, Bitcoin remains a crucial tool in daily operations, particularly given Russia's current financial sanctions.



## Felix Maradiaga - *Bitcoin Against Autocracy: A Modern Tool for Freedom* | 10:30 AM

Felix Maradiaga is a human rights advocate and leading public intellectual in the field of nonviolent resistance against authoritarian regimes. This year, he was nominated for the Nobel Peace Prize in recognition of his commitment to advancing democracy in his native Nicaragua. A former presidential candidate, Maradiaga has faced political persecution, including two years of arbitrary detention in inhumane conditions, under the dictatorship of Daniel Ortega. Felix is the president of the Foundation for Liberty in Nicaragua and the Leadership Council of the World Liberty Congress. Through these organizations, he has been advocating for the use of Bitcoin as a means to overcome the various forms of financial repression imposed by authoritarian regimes on pro-democracy activists. Felix's exceptional political acumen became evident early in his career when, at the age of 20, he assumed leadership of the Office of Economic and Social Reintegration of War Veterans. By 26, he had ascended to a cabinet position, overseeing disarmament programs in Nicaragua. Beyond his national borders, Maradiaga has made significant contributions as a consultant on post-conflict strategy in more than 45 countries. He currently serves as a distinguished member of the Board of Trustees of Freedom House, advocating for human rights and democracy worldwide. His academic credentials include master's degrees from Harvard University and the University of Barcelona, as well as a fellowship at Yale University.



## Margot Paez - A Climate Scientist's Perspective on Bitcoin Mining | 12:35 PM

Margot Paez is a PhD candidate in the civil engineering department at Georgia Institute of Technology. She has an MS in physics from GT and works on climate change statistical-based modeling, primarily in relation to water resources. Her previous research includes robotics and physics of living systems, astrobiology instrumentation, and web-based data management systems.



#### Alex Thorn - Bitcoin's American Future | 12:35 PM

Alex Thorn is Head of Firmwide Research at Galaxy Digital. At Galaxy, Alex leads a team of researchers dedicated to understanding and unpacking developments in the cryptocurrency ecosystem, producing insights for internal and external audiences. Prior to joining Galaxy Digital, Alex spent 12 years at Fidelity Investments, mostly recently co-managing Avon Ventures, the early-stage crypto venture fund affiliated with FMR LLC, the parent company of Fidelity Investments. Before that, Alex was Director of Blockchain Research at Fidelity Center for Applied Technology where he directed technology experimentation and published research on the cryptocurrency and blockchain ecosystem, and held several roles in Legal and Compliance functions before that. Alex has a B.A. in Political Science from Vanderbilt University.



#### **John Belizaire - Convergence & the Power of Bitcoin** | 12:50 PM

John Belizaire is the CEO of Soluna Holdings, the world's first utility-scale company building modular, batchable computing centers for intensive applications like Bitcoin mining, AI, and machine learning, powered by renewable energy. As a serial entrepreneur, John has successfully founded and scaled multiple industry-leading technology startups that have achieved market leadership and double-digit growth, including FirstBest, an insurance software company acquired by Guidewire, and The Theory Center, a software company acquired by BEA Systems. Before becoming an entrepreneur, John was the lead architect for Intel's Digital Enterprise Group. John holds BS and MEng degrees in Computer Science from Cornell University.



#### Ben Gagnon - How Mining Incentivizes Efficient Energy Development | 1:40 PM

Ben Gagnon is the Chief Mining Officer for Bitfarms. He has been working in the Bitcoin mining industry since 2015, after discovering Bitcoin and Crypto at the Kelley School of Business in 2010. His considerable mining and international experience includes establishing mining operations in China, Canada, and the United States, as well as founding multiple Bitcoin companies and developing technologies, including mining as a service, negative emissions mining (otherwise referred to as turn-key flare gas mitigation) and immersion cooling technology. Ben has a B.Sc. in Economics and International Business from the Kelley School of Business at Indiana University and an M.Sc. in Internet Computing and Ecommerce with a specialty in Cyber Security from Hong Kong University.



#### Josh Hendrickson - The Role of Bitcoin in the Dollar-Based System | 3:00 PM

Dr. Joshua R. Hendrickson is an associate professor of economics and chair of the Economics Department at the University of Mississippi. He is a senior fellow at the American Institute for Economic Research's Sound Money Project, a senior affiliate scholar at the Mercatus Center at George Mason University, and serves on the board of the Mississippi Council on Economic Education. Hendrickson's research focuses on the intersection of monetary theory and political economy. He has written extensively on the political economy of bitcoin.



#### Fadi Elsalameen - Bitcoin & Palestine | 3:40 PM

Fadi Elsalameen is an Adjunct Senior Fellow at the Bitcoin Policy Institute. Previously Elsalameen was a Fellow at the Foreign Policy Institute at Johns Hopkins School of Advanced International Studies and a Fellow at the American Strategy Program at the New America Foundation. Elsalameen is an advocate for Human rights, democracy, and anti-corruption with a special focus on bitcoin and crypto as a tool for freedom.



## Jeff Booth - The Future is Watching: The Discovery of an Honest and Open Protocol Changes Everything | 4:45 PM

Jeff Booth is a visionary leader, technology entrepreneur and best-selling author of <u>The Price of Tomorrow – Why Deflation is Key to an Abundant Future</u>. With his expertise in technology, system thinking and design, he is at the forefront of a transition from an economic system built for the past, and one built for the future.

Jeff has been featured in Forbes, TechCrunch, Inc.com, The Globe and Mail, BNN, Fast Company, Entrepreneur, Bloomberg, TIME, and The Wall Street Journal. In 2015, he was named BC Technology Industry Association's (BCTIA) Person of the Year, and in 2016 Goldman Sachs named him among its 100 Most Intriguing Entrepreneurs.

He is a Founding Partner of <u>ego death capital</u>, Co-Founder of <u>addy</u> and <u>NocNoc</u>. He has been a Young Presidents Organization member since 2004 and contributes time as a Founding Fellow at the <u>Creative Destruction Lab</u>. Jeff currently sits on the boards of <u>Core Scientific</u>, <u>Scoop Solar</u>, <u>Fedi</u> and <u>Breez</u>.

#### **Andrew Bailey**

Andrew M. Bailey is an interdisciplinary teacher and scholar whose work spans philosophy, politics, and economics. He is an Associate Professor of Humanities at Yale-NUS College (Singapore), a BPI Fellow, and one-third of Resistance Money, a Bitcoin research collective.



#### **Bradley Rettler**

Bradley is an Assistant Professor of Philosophy at the University of Wyoming, where he teaches classes on metaphysics, ethics, and bitcoin. He is a founding member of Resistance Money, a Bitcoin Research Collective. He received his PhD from the University of Notre Dame in 2014.



#### **Craig Warmke**

Craig (Ph.D., UNC - Chapel Hill) is an Assistant Professor of Philosophy at Northern Illinois University. He has published peer-reviewed articles about the nature and function of bitcoin and is currently writing an academic book about bitcoin with Andrew Bailey and Bradley Rettler. Craig is also a member of the advisory panel on cryptoassets for the Law Commission of England and Wales and writes for the financial services startup, Atomic Finance.

## Regulating Digital Assets: A Fireside Chat with Rep. Patrick McHenry



#### **David McIntosh**

David McIntosh is a leader for the principles of limited constitutional government and individual freedom. He is the President of the Club for Growth, the leading advocate for economic liberty.

Former Congressman David McIntosh represented Indiana's 2nd Congressional District in the United States Congress from 1995-2000. David served during the Reagan administration as special assistant to Attorney General Edwin Meese III, and as special assistant to President Reagan for Domestic Affairs. During the first Bush administration, he served as executive director of the President's Council on Competitiveness and assistant to the Vice President.

David co-founded the Federalist Society for Law and Public Policy and serves on the Board of Directors. He remains active with several free market and conservative think tanks and grassroots organizations. David has also had stints at the Hudson Institute and as a Professor of Economics at Ball State School of Business. Prior to the Club for Growth, David was a partner at Mayer Brown, LLP in Washington, DC.

David graduated from the University of Chicago Law School in 1983, and Yale University, BA, cum laude, in 1980. He is the proud father of two adult children, Ellie and Davey.



#### **Congressman Patrick McHenry**

Representative Patrick McHenry represents North Carolina's 10th District in his tenth term, covering parts of nine counties. As Chair of the House Financial Services Committee in the 118th Congress, he advocates for banking access and credit for families and small businesses.

Previously, McHenry was the Republican Leader and Vice Chairman of the Financial Services Committee, as well as the Chief Deputy Whip, where he played a key role in passing the Tax Cuts and Jobs Act. He has also focused on supporting entrepreneurs, authoring the "RAISE Act" and legislation for equity-based crowdfunding, both signed into law, earning him accolades in crowdfunding and finance innovation.

McHenry has been an advocate for veterans, securing a health care clinic in his district, and has received numerous awards for his conservative leadership and support of small businesses, manufacturing, and taxpayer rights. Before Congress, he served in the North Carolina House and the U.S. Department of Labor. McHenry, a Belmont Abbey College graduate, lives in Denver, N.C., with his wife Giulia and their three children.

## Mining in America: A Fireside Chat with Senator Cynthia Lummis



#### **Fred Thiel**

Prior to serving as Marathon's chief executive officer, Thiel co-founded and served as chairman of Sprocket, a blockchain and cryptocurrency technology and financial services company whose mission is to reduce the risk and friction of cryptocurrency trading across marketplaces, regions and exchanges by establishing a federation of exchanges that together create a single aggregated global trading marketplace with large scale liquidity, rapid execution, minimal counter-party risk, and price transparency. Prior to that, Thiel served as chairman and chief executive officer of Local Corporation, an \$80 million Nasdaq-listed leader in online local search and digital media, mobile search monetization and programmatic retargeting markets with over 240 million unique annual visitors. During his career while holding the title of CEO across multiple companies, Thiel successfully created in excess of \$750 million in shareholder value, efficiently raised more than \$150 million through both public (IPO and secondary offerings) and private capital sources, led multiple successful corporate transformations resulting in highly accretive exits, built high output agile product development organizations, and established corporate innovation groups resulting in the creation of new product businesses that generated significant new revenues in their first year.



#### **Senator Cynthia Lummis**

Cynthia Lummis, sworn in as the first female U.S. Senator from Wyoming on January 3, 2021, has a rich background in public service and advocacy for her state. Born and raised on a Laramie County cattle ranch, she has dedicated her career to supporting Wyoming's families, businesses, and values. Lummis, who first entered the U.S. House in 2008, is known for her conservative stance and was a founding member of the House Freedom Caucus. Throughout her tenure, she has focused on fiscal responsibility, western issues, and energy resources, notably chairing significant appropriations bills and advocating for public land use. Before her Congressional service, she was Wyoming's State Treasurer, served in the State Legislature, and held various legal roles, including working for the Governor and the Supreme Court. After leaving Congress in 2016, she managed family ranching operations. Lummis holds degrees in animal science, biology, and law from the University of Wyoming. She was married to Al Wiederspahn, with whom she has a daughter, Annaliese, a son-in-law, Will Cole, and three grandsons.

#### **Jason Les**

Jason joined Riot in 2017, initially as a member of the Advisory Board before being asked to join the Board of Directors later that year. Alongside Riot's strategic transformation, and the reconstitution of its Board of Directors and management team, Jason became Chief Executive Officer in February 2021. Jason is the driving force behind the mission to make Riot one of the most significant players supporting the Bitcoin network. Jason's passion for Bitcoin dates to 2013, where he gained significant experience in cryptocurrency mining, protocol development, and contributing to open-source projects. He is deeply committed to the advancement of Bitcoin and his technical expertise plays an integral part in Riot's strategic decision making. Jason's experience extends beyond the world of Bitcoin. He was a founding partner of Binary Digital, where he led the engineering team and coordinated the development of projects ranging from artificial intelligence to reverse engineering and inter-software compatibility. Jason's ability to navigate complex technical challenges with ease and precision is a testament to his leadership skills. Jason also brings a unique background as a former professional heads-up poker player to Riot. He successfully competed in high-stakes games online and the most prestigious, highstakes tournaments worldwide. In 2015 and 2017, he was selected as a human benchmark for testing the world's best poker artificial intelligence in what was dubbed "Man vs Machine" at Carnegie Mellon University. This experience instilled in Jason the discipline, focus, and strategic thinking that he applies to his work today. Jason holds a Bachelor of Science in Information & Computer Science from UC Irvine. He is dedicated to achieving excellence in his work and making a meaningful impact in the world of Bitcoin technology.



#### **Paul Thanos**

Paul J. Thanos is the Director for Finance and Professional Services at the U.S. Commerce Department's International Trade Administration. Mr. Thanos is responsible for developing and executing policy, analysis, and promotion initiatives pertaining to finance and insurance industries, business and professional services, trade and project finance and sustainability. Mr. Thanos is an interagency leader on digital assets and Web3 including leading the Commerce Department's work on responsible development of digital assets. Mr. Thanos leads an initiative on the future of work and competitiveness which includes examining issues such as talent pipelines, portable benefits, and independent work. He leads the U.S. delegation to the OECD Insurance and Private Pensions Committee and supervises the Commercial Pillar of the US-UK Financial Innovation Partnership. He is a regular guest lecturer on topics ranging from trade, competitiveness, corporate strategy and value creation, and risk management. Mr. Thanos served as the inaugural Global Trade and Investment Fellow at the Woodrow Wilson International Center for Scholars in 2016-17 where he published a series of articles on inclusive capitalism, services trade, and US-Canada bilateral economics in the Great Lakes region. He also served as a Brookings Institute fellow in the United States Senate with responsibility for trade, foreign policy, and defense issues.

#### **Grant McCarty**

Grant McCarty is the Co-Founder and Co-Executive Director of the Bitcoin Policy Institute. Before founding BPI, Grant built an education startup dedicated to reducing inequity in college admissions, worked at a fintech startup focused on democratizing investment access in the US, and led policy efforts at BTC Inc -- the largest media company in the Bitcoin industry. He received his undergraduate degree from the University of Alabama and his MBA from Johns Hopkins University.



#### **Chastity Murphy**

Chastity serves as a Senior Advisor to the Assistant Secretary of Financial Institutions, where she oversees the activities of four distinct offices. Her direct responsibilities include managing areas such as cryptocurrency, digital assets, consumer protections, and financial inclusion initiatives. In addition to her primary duties, Chastity contributes her expertise to the Counselor for Racial Equity and engages in special projects focusing on technology, inclusion, and access initiatives under Deputy Secretary Adeyamo.

Her commitment to public service is driven by a desire to enhance opportunities for women and contribute to America's prosperity.

Blackburn's journey in public service began in 1995 as the executive director of the Tennessee Film, Entertainment, and Music Commission. By 1998, she secured a seat in the Tennessee State Senate, where she was recognized for her fiscal discipline and solutions to budgetary challenges. Notably, Blackburn spearheaded a successful campaign against a proposed state income tax, culminating in a constitutional amendment in 2014 to ban it.

Elected to Congress in 2002, Blackburn was known for her advocacy of small, efficient government and her role in protecting the rights of songwriters and performers. She chaired the Energy and Commerce Committee's Subcommittee on Communications and Technology, demonstrating a bipartisan approach to legislation.

An active participant in charitable organizations and her church, Christ Presbyterian, Marsha lives in Williamson County, Tennessee, with her husband Chuck. They have two children, Mary Morgan and Chad, along with three grandsons and a granddaughter. Originally from Laurel, Mississippi, Blackburn is a Mississippi State University alumna, reflecting her deep-rooted southern values and commitment to public service.

#### Roya Mahboob

Roya Mahboob is an Afghan tech entrepreneur and the founder of Citadel Software, a software development company based in Herat. In addition to being one of Afghanistan's first female tech CEOs, Mahboob founded the Digital Citizen Fund, a nonprofit that aims to increase women's technological literacy and provide employment and educational opportunities for girls in Afghanistan. Mahboob was named one of TIME's 100 Most Influential People in the World in 2013 for her innovative initiatives to expand computer education. She has created nine IT centers for girls in high schools across Afghanistan and plans to expand her programs to 40 schools, ultimately reaching more than 160,000 female students. Mahboob has also taken her model beyond Afghanistan to schools in Bangladesh, India, Pakistan, and Nepal. After facing death threats from the Taliban and others for her work, Mahboob left the country in 2013 and spent two years working remotely before returning to Afghanistan in 2016. She founded the Afghan Girls Robotics Team, also known as the Afghan Dreamers, an all-girl robotics team.
